- If you don't have access to a computer, you can collect a paper form from the Welcome Desk and return it to the Parish Office when completed in an envelope marked "Planned Giving".
- If you pay tax, please fill in the Gift Aid Declaration on the form. HMRC will then refund to All Saints 25p for every £1 that you give - at no cost to you.

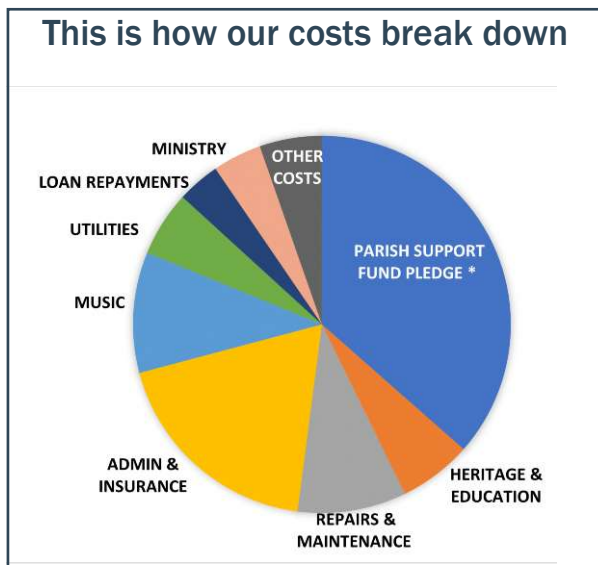
Playing your part

Our Costs

It will cost over £340,000 this year to run this historic church and keep it open, 7 days a week.

We also have several major capital projects this year - upgrading the church lighting system, essential works on the organ and improving A-V facilities in the Heritage Gallery.

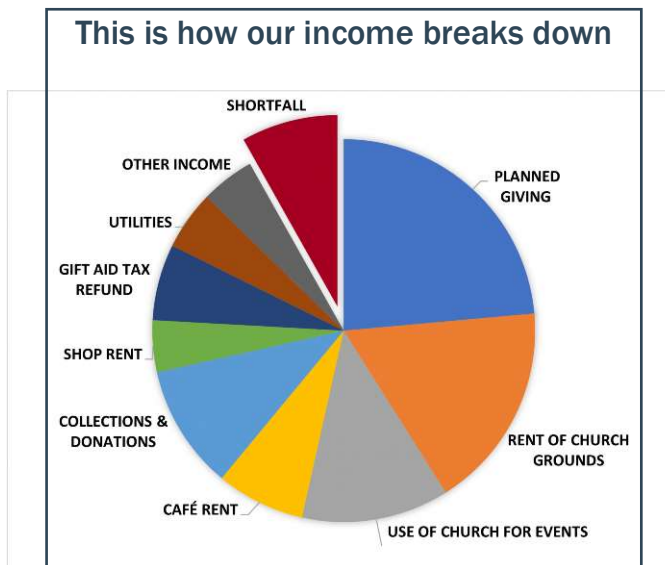
In addition, 2023 sees the statutory Quinquennial Inspection to identify any major work that may be needed on our Grade 1 listed building.



Our Income

Our expected income from all sources this year is around £315,000.

This includes planned giving under our Planned Giving Scheme, use of the church by external organisations for concerts, etc., rent for running the children’s entertainments and the Christmas Market on the north lawn, rent of the café in the east end and rent of shop owned by the church in Union Street.



Our Future

- Running the church and keeping it open costs **over £6,600 per week, or more than £940 every day.**
- We have to raise ALL of this money ourselves - we receive no external funding.
- While we work hard to maximise income from a variety of sources, Planned Giving is still our principal source of income.
- We are hugely grateful for those who use Planned Giving. We would not have survived the COVID pandemic without your continued generosity.
- However, we need to increase our income from Planned Giving by at least £20,000 if we are to be able to face the future confident that we will have the resources to expand our mission and maintain All Saints’ position at the heart of Kingston life.

*The Parish Support Fund is the method through which parishes are asked to fund God’s mission and ministry, mainly to pay clergy and clergy housing costs.
